DECLARATION

In the College Admission of 2021-22, some extra students, beyond the earmarked admissible capacity, had to be accommodated in the B.A. General Program, simply because during the Covid Pandemic Years, all Students who sat for Higher Secondary (Class XII Board Examination) had passed, and there was enormous pressure to accommodate student who pleaded for Admission, along with their Guardians, lachrymose and in folded knees Accordingly, with all alternative, and with consent from the Higher Authorities, the College accommodated the extra students and later got it endorsed through the affiliating University=- WBSU. WBSU permitted us to accommodate 326 Extra students who had applied for admission, but finally 269 extra students took admission, primarily in B.A. General Program. Consequently, the intake capacity of B.A. General for the academic session 2021-22 became 2666 in lieu of 2397. It is also intimated in this context that most of the admitted students belonged to the General Category; and hence the number of increased the General category Students is 1609 in place of 1466, i.e., 143, extra students.
